Why & What

* WHY *

- All countries that signed the Convention are obliged to and are responsible for the implementation of all reporting obligations.
- National Reporting Obligations (NROs), which help Contracting Parties achieve the objectives of the IPPC Convention.
- All reporting obligations have the same legal value and are of equal importance.
- The purpose of the IPPC NROs is not to fulfill the obligations for its own sake.
- "Rather, fulfilling the obligations is a means to an end"
- "International cooperation in controlling pests of plants and plant products and in preventing their international spread, and especially their introduction into endangered areas"

- Control of pests of plants and plant products as well as prevention of international spread of pests.
- Promotion of the country's international trade.
- Safeguarding of food security and protection of environment.
- Establish transparent communication which will facilitate cooperation and coordination between IPPC Contracting Parties;
- Build trust in bilateral relationships between IPPC Contracting Parties over time;
- Provide an indication of an establishment of the NPPO and its effective functioning.

Nepal's Agriculture

- Low productivity, inadequate infrastructure and reliance on rain-fed traditional agriculture.
- Net-importer of most of the agriculture goods and lacks competitiveness in global trade market.
- Inadequate Compliance with international standards" One of the important factors preventing Nepal from reaching its export potential for agro-products
- Harmonization of standards also limits trade with partner countries.
- In this connection, fulfillment of "NRO" could play an instrumental role in promoting exports.

Top agri-foods/items exported by Nepal

Water, nutmeg, cardamoms, animal fats, vegetables, legumes, and vegetable products, tea, oil cakes, other solid residues, nuts, plants and parts of plants

Top agri-food commodities imported by Nepal

Rice, soybean oil and its fractions, maize, oil cakes and other solid residues, palm oil and its fractions, vegetables and dried legumes, apples, pears, and quinces, other food preparations, raw wool, and nuts.

Top trading partners

- Nepal is an import-dependent country, especially with its regional neighbors.
- Its top bilateral trading partners in agri products include India, Bangladesh, China, Egypt, Thailand, USA, Vietnam, Singapore, Malaysia, UAE and UK.

Key benefits to be gained from fulfillment of NROs

- 1. Win "the trust" of Nepal's trading partners;
- 2. Increase "market access" and facilitate "safe international trade";
- 3. Enable importing countries to more accurately determine "phytosanitary requirements";
- 4. Decrease number of "interceptions/rejections of non-compliant consignments"; and
- 5. Avoid phytosanitary disputes & facilitate resolution of non-compliance incidents.





National Reporting Obligations: Overview

In total there are 13 National Reporting Obligations:

- Designation of an Official IPPC Contact Point;
- Description of the NPPO;
- Phytosanitary requirements, restrictions and prohibitions;
- List of entry points;
- List of regulated pests;
- Pest reports;
- Organizational arrangements for plant protection;
- · Rationale for phytosanitary requirements, restrictions and prohibitions;
- Significant instances of non-compliance with phytosanitary certification;
- The result of investigation regarding significant instances of non-compliance with phytosanitary certification;
- Information on the pest status;
- Emergency action;
- Technical and biological information necessary for pest risk analysis.

NROs by a method of reporting

As regards a method of their communication there are seven public NROs which should be reported via the International Phytosanitary Portal (IPP – https://www.ippc.int):

- Designation of an Official IPPC Contact Point;
- Description of the NPPO;
- Phytosanitary requirements, restrictions and prohibitions;
- · List of entry points;
- List of regulated pests;
- Pest reports;
- Emergency action.

There are also six bilateral National Reporting Obligations which should be communicated directly between Contracting Parties:

- Organizational arrangements for plant protection;
- · Rationale for phytosanitary requirements, restrictions and prohibitions;
- Significant instances of non-compliance with phytosanitary certification;
- The result of investigation regarding significant instances of non-compliance with phytosanitary certification;
- Information on the pest status;
